Present and Past Performance

Aseptic Hospital Housekeeping - U.S. Army – MEDCOM

AFSI has performed in critical federal medical hospitals, clinics, trauma centers, and labs, such as U.S. Army – MEDCOM, to optimize cleaning practices prescribed and endorsed by the Association for the Healthcare Environment. Provide Type I Services – (Surgical Areas), Type II Services – (Patient Areas), Type III Services – (Restrooms), Type IV Services – (Clinical/Support Areas), Type V Services – (Administrative Areas), and Type VI Services – (Common Areas).

Base Operations Support Services (BOSS)- Marine Corps Air Station Beaufort

ATSI wase the Prime contractor for 10 years providing BOSS at the Beaufort Marine Corp Air Station. Our contract included scheduled and unscheduled services to more than 300 buildings / structures all totaling 3,612,841 sf on 6,900 acres. Building types included a multi-floor 30,206 sf headquarters office, a multi-floor 102,000 sf Pilot Training Center, schools and childcare centers each more than 20,000 sf, as well as recreation facilities, hangars, community and recreational facilities, police and fire departments, vehicle maintenance facilities and administration buildings.

Environmental Remediation and Waste Management (ERWM) - Dept. of Energy (DOE)

AFSI for two contract cycles supported DOE's ERWM Program. Services included soil and groundwater characterization/remediation, soil excavation and hauling, soil and waste disposal, waste management, associated regulatory documentation preparation, and reporting requirements.

Military Family Housing Maintenance - Dept. of the Air Force AFSI provided Emergency, Preventive and Routine Maintenance and Repair services for 741 housing units, 24 /7/365. We performed ground maintenance for 796 irrigation systems, maintained 490 backflow preventers, street sweeping of 28 miles of roads and parking lots, and painted over 667,212 SF of interior areas.

<u>Armed Security Officer Services - U.S. Coast Guard & U.S.</u> Marshals Service

Experienced in a variety of security applications, APSI manages and operates geographically dispersed contracts; complex security operations around waterfront facilities; as well as in remote locations, high-risk environments, at CONUS and OCONUS locations. 24 x 7 x 365, safeguarding people, federal facilities, assets, critical infrastructure, and live toxic agents. We provide access control; contraband detection using x-ray screening equipment; walk-through metal detectors and hand-held metal detection wands; interior and exterior coverage; roving and fixed posts; security control centers operations, including CCTV monitors; traffic control enforcement, vehicular barrier operations; and escort services.

Fire, Emergency Management and Emergency Medical Services (FEMS) - U.S. Air Force Cape Canaveral Space Force Station

APSI provided 70 FF/FF Paramedics, 24/7/365 for Fire Prevention, Emergency Management & Emergency Medical Services (FEMS) III, including Specialized Firefighting (exotic fuels & materials), Rescue (aircraft, astronaut/pilot/high-angle/water) and a full range of emergency medical services, as well as emergency management for all events. We managed events for Government and commercial clients including SpaceX, Blue Horizon, and other private companies utilizing this space launch facility.

Operations and Maintenance (O&M) Services - Food and Drug Administration

AKHI is the Prime contractor responsible for maintaining all spaces in the highest state of cleanliness. O&M services include facility operations and preventive maintenance; repair services for buildings, structures, building equipment; and general maintenance. Our eight full-time employees provide 16,640 annual hours of services and perform more than 300 preventative maintenance annually on equipment. AKHI provides all required contractor furnished equipment/vehicles and contractor furnished restroom supplies. We utilize CMMS Archibus for records maintenance. Personnel hold Public Trust Clearances.
